



CODE OF THE CABINS

- **Peak Season General Store Hours** (October 1 – May 31): Monday - Sunday: 8am – 5pm
- **Off Season General Store Hours** (June 1 – September 31) Monday through Sunday: 8am – 4pm
- **24 Hour Security** call 863-801-1095 (Trevor Shannahan) | Emergency call 911
- **Main Gate** is **LOCKED** when Club and General Store is closed. Guests must use Access Gate in front of **FARM HOUSE** to enter/leave the property. **After Hours ACCESS GATE Code: 5555#**
- **Corral Continental Breakfast** is served in the General Store lounge from **7:30am – 9:30am**
- **GUEST CHECK-IN: 3:00PM**
- **GUEST CHECK-OUT: 11:00am.** Please inform reception if you wish to retain your room beyond this time.. If the room is available, the following fees will be charged:
 - **Members: 12pm – Courtesy;**
 - **Non-Members – 12pm – 1pm: \$25; 1pm - 2pm; \$50; 3pm - 4pm - \$One night stay.**
- **Complimentary WIFI:** OK Corral Guest | No Password Required
- **ALLEN STREET Quiet Time:** 11:00pm – 7:00am. Please be considerate of other guests.
- **Cleanliness:** Please do not use bath towels, hand towels or washcloths to clean golf cart seats, wipe your feet, or clean up after your pet; or, an extra \$100 cleaning fee will be charged
- **Keys:** Keys not turned in upon checkout will be subject to a **\$50 fee.**
- **Bonfires:** We will discontinue our Bonfires from June 1, 2021 through September 30, 2021
- **Personal Golf Carts** must stay in the Lodging area after dark. Mining Town Lodging boundaries stop at the end of Allen Street, Mine Shaft Tunnel North of the Cart Path and back of the General Store.
- **Golf Carts and Side by sides are permitted.** We do not allow ATV's, dirt bikes or go-carts
- **Pet Policy:** 1 Pet \$50.00. 2 Pets \$75.00. Pets must be kept on leash at all times. Please clean up after your pet. A doggie station is provided for your convenience. If your pet sheds badly, we will charge an extra \$50 clean up fee
- **Service Animals:** Under the ADA, service animals are dogs that trained to do work or perform tasks for people with disabilities, and must be under the control of its handler. Dogs whose sole function is to provide comfort or emotional support do not qualify as service animals under the ADA, the regular fee as stated under our **Pet Policy.**
- **Smoking:** No smoking in cabins or any other buildings. A fee of up to \$250 will be assessed for smoking in a Cabin room.
- **Illegal Substances:** No illegal substances allowed on premises
- **Property Access:** Limited access to property beyond the Cabins and Allen Street is in effect upon dusk.
- **Room Damage / Property Damage:** Registered guest is responsible for any loss or damage, including damage to lawns or roads to the OKC property caused by themselves, their guests or any person for whom they are responsible. **Any form of damage or destruction** will immediately result in an assessment fee determined by OKC management
- OKC Management has the right to request any guest to vacate his/her room or other areas of the hotel forthwith and the guest shall be bound to vacate when requested to do so. In case of the default, the Management has the right to remove the Guest luggage and belongings from the room occupied by him/her.
